<b>1</b>	<b><i>Introduction to our solution</i></b>	
1.1	Zeph introduced the various hardware and software we are using. He started off with the introduction of the raspberry pi and thermal camera component. Did a short demo with a lighter and pearlyn went on to show how the dashboard works (explanation of different status)	
1.2	Kelvin asked how to program it to detect a real fire. Zeph explained how we use both the thermal camera and computer vision model as a two step confirmation to determine whether it is a fire. Zeph also showed an example of a testing(burning of incense paper) we did previously to give Kelvin a better idea.	
1.3	Kelvin also suggested us to remove detection of smoke because during the fumigation process, it may cause a false alarm which defeats the purpose of our solution.	
1.4	Kelvin asked what are the criterias and our thresholds for the thermal camera. Zeph replied that our current threshold for temperature is 60 degree celsius and clarified that we wrote the program ourselves.	

1.5	Zeph asked whether there are any suggestions for the dashboard. Mr Kelvin, how do we program the location of the camera? Zeph explained that we used lat,long for the location of the camera. We can increase granularity of the location by adding more decimals, even though our system does not have a GPS we can indicate manually to each individual camera for better accuracy.

2.1	Henry mentioned we have created two personas based on our previous interaction and feedback. He shared both personas and waited for Kevin to reply.	
2.2	Kelvin shared that there is a middle man(DECAM services) that is the communication portal between SCDF and the relevant stakeholders. He also mentioned that for our solutions, it will not remove the smoke detector system entirely but it can be an add on.
